Healthium UK is committed to achieving Net Zero emissions by 2045.

Baseline Emissions Footprint

Baseline Year: 2023-2024

Additional Details relating to the Baseline Emissions calculations.

Healthium UK, as a newly formed subdivision of Healthium, has no existing emissions reporting or baseline figures from which to measure carbon reduction towards our net zero plans. However, Healthium UK is currently working on developing a robust Carbon Reduction Plan that will facilitate our aim to be net zero by 2045. Our parent company Healthium has conducted a significant analysis into its overall GHG emissions for its total combined global presence from which Healthium UK will be able to derive its individual contribution.

It is Healthium UK's plan to work collaboratively with our parent company Healthium, our logistics and distribution partners, and the procured services of an expert external body to define our Carbon Reduction Plan and report baseline figures by year 2024-2025 and delivery of net zero emissions by year 2045.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we will be adopting a range of reduction targets that will cross GHG output from Scopes 1 to 3.

In order to calculate the exact reductions target %s we will first complete our initial assessment of our newly formed entity, Healthium UK, to be able to quantify our current emissions and planned reductions.

Once mapped we will provide a graph depicting our planned reduction target and how we are tracking against that year on year.



Carbon Reduction Projects

No management measures and projects have been completed or implemented since the 2023-2024 baseline. The carbon emission reduction achieved by these schemes therefore equate to 0 tCO2e, or a 0% reduction against the 2023-24 baseline year.

As this is the first year of reporting there are no quantified savings from carbon reduction projects to report.

Historically we have moved to a remote based working model with no central office facility reducing carbon footprint through energy and water supply to a communal working space and removing commuting requirements. This however was not tracked or measured as it occurred prior to our working on the Carbon Reduction Plan.

In the future we hope to implement further measures such as:

Potential carbon reduction plans may include, but not necessarily be limited to:

- increasing ratio of recycled materials in packaging
- increasing ratio of recycled materials in raw materials procurement
- expediting move to hybrid or electric vehicles for fleet cars
- continuing to improve forecasting and supply processes to reduce shipping containers and combine deliveries
- moving to eradicate air freight from logistics routes
- improving commuting efficiency and using public transport where possible

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.
